(Complaint registered before the Chief Judicial Magistrate, Karimganj, Assam against several Government Officials (Assam Police/Forest Force) threatening of evicting people from their homestead as a means of garnering support in favour of the Bharatiya Janata Party Candidate from Karimganj Lok Sabha Constituency.)

(3) Complaint before the Returning Officer, HP-7, Karimganj Constituency, Assam filed on 17/04/2024 by Hafiz Rashid Ahmed Choudhury, Contesting Candidate, HP-7, Karimganj Parliamentary Constituency, for the Indian National Congress.

Respected Sir,

With reference to the above mentioned subject, I would like to inform you that on 06/04/2024 and thereafter, in election campaign meetings held in places such as Ratabari, Ram Krishna Nagar, Patharkandi area, Shri Bijoy Malakar, MLA, Ratabari Assembly Constituency (Under Karimganj Lok Sabha Constituency) representing the Bharatiya Janata Party, had openly threatened muslim voters, using loud speakers as well as by approaching them, directing the muslim voters to vote in favour of Shri Kripanath Mallah representing the Bharatiya Janata Party Janata Party or else all muslim voters would face the consequence of being evicted from their homestead land by using Bulldozers / JCBs. Complaint in this regard had already been filed before different authorities of the Election Commission along with video footage as proof. An FIR being Ratabari PS Case No. 91/2024 U/S 153(A)/ 171(F)/ 171(F)/ 120(B) IPC against Shri Bijoy Malakar was also filed and registered.

Since 21/04/2024, several Government Officials belonging to the Forest Department of the Government of Assam and personnel belonging to the Assam Police had been visiting several villages, day and night, creating havoc by threatening local residents of the villages under the Ratabari Police Station of evicting them if they do not cast votes in favour of the BJP candidate. During this period, the Forest Officials / Police personnel/ Commandos etc. went house to house in areas lying under Ratabari Police Station, Bilaipur area of Hailakandi District and areas falling under Patharkandi, Assam, calling the residents of individual houses out of their houses, asking them to stand in front of their individual residences for taking photographs. They were then warned that if they do not cast votes in favour of the BJP candidate Kripa Nath Mallah than their houses will be demolished by using Bull-Dozers. Being aggrieved, some of the victims had filed a Complaint before the Court of the Chief Judicial Magistrate, Karimganj on 24/04/2024 which is registered as CJM Karimganj, CR Case 446/2024 under Sections 504/506/120 B and 171 F of IPC, Soidul Ali & others -vs- Mr. M. K. Yadav, IFS & Others.

Sub: Ejahar on deliberate provocations to Muslim people against Hindu people to promote disharmony, enmity, feelings of hatred, ill-will between Hindu-Muslim communities and insulting Islamic religion of Muslims, openly, blatantly, using microphone in public meetings, and making it viral in social media.

Most respectfully I the undersigned would like to draw your good self's kind attention to the following facts for your kind perusal and early necessary action as per law:

For last few days a video message was made viral in the social media, copy of which is also sent to my mobile phone by many of my known persons/friends, in many WhatsApp groups, on Facebook page, Instagram etc. which has come up on many News Portals, electronic and print media also.

In this video it is found that, the accused Bijoy Malakar, standing MLA of Ratabari LA Constituency, in spite of being a constitutional person, having taken oath of allegiance and respect to Indian Constitution, is threatening the Muslim people of the areas in a public meeting on 06/04/2024, using loud microphone and asking Muslim people to leave their religion if their religion stops them to vote for BJP candidate Sri Kripanath Mallah.

In the same Video he is also found seriously threatening the Muslim voters of the area to vote for BJP Candidate Sri Kripanath Mallah and if he do not find their vote on counting day on 04/06/2024 then he will send Bull-Dozer/JCB on 07/06/2024 and will evict them from their home-stead land as he himself knows where they used to reside. The accused made the video aired live on his own Facebook account and tagged with most of Facebook accounts of BJP high commands and also made the video viral on social media.

The accused is deliberately and very recklessly trying to break the age old Hindu-Muslim unity and peaceful co-existence for nasty intentions and thus to cause communal riot, by provoking Muslim people against Hindu people. As a result there is an under-current of communal tension in the entire district and in

the Barak valley region, including Badarpur area. The video is also made viral in the Badarpur area, hence the FIR is filed with this Badarpur PS.

Though many well wishers of mine are suggesting me not to file this case as because I may be personally attacked/harassed/ false criminal case/s may be filed against me, anywhere in India, including false NDPS case/ by planting contraband substance, but if such deliberate attempts to create communal tensions is not checked our society will be torn in to pieces by those miscreants. Anticipating such possible harassment many people are unable to gather courage to file any *FIR against* those high and mighty.

There is deep conspiracy to create communal tension and disharmony by the accuseds, for long, as because none of the higher ups tagged with their facebook account of this video, has either apologised, deletd, disowned the video till date, for which I waited for so long, hence the delay in filing this FIR.

Under the circumstances your good self may be kind enough to register a case under appropriate sections of law including section 153A /171C / 171F/120B of the IPC and to make investigation in to the matter and to take appropriate action as per law.

Sub: Blatant violation of Model Code of Conduct on 06/04/2024, in election meetings in public, by Sri Bijoy Malakar, standing BJP MLA, from Ratabari, Constituency, Karimganj, the authorized person of BJP Contesting Candidate Sri Kripanath Mallah, using undue influence, threatening the Muslim voters en-masse of the Ratabari, Ram Krishna Nagar and Patherkandi area to vote for BJP Candidate Sri. Kripanath Mallah or else will be evicted from their home-stead lands on 07/06/2024 using Bulldozer/JCB, also asking Muslim voters to leave their religion if it stops them to vote for BJP.

Sir,

With reference to subject captioned above the undersigned INC nominated contesting candidate from H.P.7, Karimganj Constituency, would like to draw your kind attention to the fact that one Sri Bijoy Malakar, standing BJP MLA, from Ratabari, Constituency, Karimganj, the authorised person of BJP Contesting Candidate Sri Kripanath Mallah, using loud speaker, openly in public meeting at Patiala, of Ratabari area, on 06/04/2024, threatening the Muslim voters of the area to vote for BJP nominated contesting Candidate Sri. Kripanath Mallah or else will be evicted from their home-stead lands, by using Bull-Dozer/JCB on 07/06/2024, after counting votes and also recklessly asking Muslim voters to leave their religion if it stops them to vote for BJP.

That it is known to all that about 15 to 20,000 (Twenty Thousands) Minority Muslim residents in Patharkandi, Ratabari and Ram Krishna Nagar area who were residing for 40/50/60/70 years were **selectively**, based on religion, evicted in 2022 from their home-stead land forcibly, suddenly and very hastily without serving any notice duly, even without giving minimum opportunity of hearing, to the victims, very illegally, in violation of all standing laws, Supreme Court Judgments, High Court Judgments, International Covenants, United Nation's Resolutions and even in violation of natural justice, falsely and intentionally branding them as **migrated Ruhingiays** by the BJP Party and BJP Govt. in power, very inhumanly at the time of the then ongoing high flood in the district. Till now most of them are living in temporary sheds, or under open sky or below the trees.

That Sir in many ongoing election public meetings in Pathrkandi, Ram Krishna Nagar and Ratabari area, Sri Bijoy Malakar, the standing BJP MLA from Ratabari Constituency, and his party associates in front of many state level office bearers of the party on the stage, very blatantly, openly with loud speakers repeatedly

threatened the Minority Muslim Voters and intimidated them to vote for BJP candidate Sri Kripanath Mallah, or else they will evict the Muslim Voters by Bulldozer/JCB on 07/06/2024 after counting of votes on 04/06/2024. Such a violent use of undue influence is required to be checked at once and punished.

I have obtained video footage of one of such threatening and intimidating speeches of Sri Bijoy Malakar which is enclosed herewith in a Pendrive, (Memory Card) for your kind examination and verification. I have synchronized the relevant parts of the video footage of only 125 seconds from the entire video, both the full video footage and relevant footage of 125 seconds are enclosed herewith.

That Sir, with great shock and surprise, in this video footage he has also very violently asked the minority Muslim Voters to leave their religion, if it stops them from voting for BJP.

That Sir, the BJP party and its contesting candidate from Karimganj is also trying to create communal riots, by breaking age-old Hindu-Muslim unity, harmonious co-existence, which is their known party culture, by dangerously provoking the Minority Muslims, against our Hindu-Brethren as stated above and openly and publicly compelling the minority Muslims to vote for BJP candidate, which is a serious crime under section 153A/171C/171F and 120B IPC and gross violation of section 123 (2) of the Representation of People Act, 1951. Thus they are deliberately and repeatedly trying to create serious Law and Order situation in the entire country, in the entire state of Assam, and in the districts of Barak Valley in particular (Districts of Karimganj, Hailakandi and Cachar).

That Sir this crime in the video footage is committed on 06/04/2024 and same video footage was uploaded live on Facebook by Sri Bijoy Malakar and tagged with Face book accounts of many BJP party leaders including BJP national slogan face book account <u>#AbkiBaar400Paar</u>, <u>Chief Minister Sri Himanta Biswa Sarma</u>, <u>BJP State President Sri Bhavesh Kalita</u>, <u>Ravindra Raju</u>, <u>Minister Pijush Hazarika</u>, <u>Minister Jayanta Mallabaruah</u>, <u>MP Pabitra Margerita</u>, <u>BJP Assam Pradesh</u>. But unfortunately none of them and even the candidate took any action like apology, deletion, clarification, rather it is deliberately made viral till date in the Social Media, which further confirms the according of consent by all those, to such undue influence, intimidation, open threat and deliberate attempts to create communal dis-harmony among the Hindu-Muslim people living with peaceful co-existence since centuries.

Kindly see how the insulting word **"Tumra"** (means You people, in derogatory sense) he used repeatedly to address the Muslim Voters present and absent.

Under the circumstances free, fair and peaceful election is quite impossible if appropriate action is not taken at the earliest against the openly declared Goondaism, , and there is every possibility of creating uncontrollable law and order situation, by those miscreants/ BJP leaders.

Under the facts and circumstances I earnestly request your good-self kindly (i) to take immediate and appropriate necessary legal action against the accused/s, (ii) against the BJP candidate (iii) to arrest them and put them in custody, so as to enable the already threatened and intimidated voters in Patherkandi, Ram Krishna Nagar and Ratabari area, cast their vote freely, fairly and peacefully and (iv) cancel the candidature of the BJP nominated candidate Sri Kripanath Mallah, as per law and (v) to provide full-proof security in the Patharkandi, Ratabari and Ramkrishna Nagar area at the earliest possible, so that already threatened and intimidated victim Voters can attend the meetings of political party/ies of their choice and then can cast their vote freely, fairly peacefully and free from existing, threatened, tensed and charged atmosphere created by the BJP leaders.




MOST RESPECTFULLY SHEWETH:

1. Most respectfully the above named complainants begs to state that we are the permanent residents of the above mentioned address, residing for 50/60 years including our parents and fore



fathers and are the citizens of India and are entitled all therights and privileges guaranteed by the Constitution of India and the laws framed there under.

- 2. That since last 3 days the accuseds along with, many other staff along with Assam Police Commando/Forest Force in 40/45 numbers in black attire, Armed Police, Armed Forest Guard, are going house to house in day and in night in Butukusi, Rongpur, Cheragi, Jalalaavad, Nivia, Sonapur, Kalamagura, Kalagang, Vittor Balia, Balia, Kamor Ma, Chuto Balia, Boro Balia, Gua Ura, Choutish, Monishtopur, Monpur, Dolugang, under Ratabari Police Station area, and Bilaipur area of Hailakandi District, and Lowairpoa, Nagra, Kotamoni, Patiala, Isarpar, Zerzeri, Bali Pipla, Longai area of Patharkandi area, and asking the residents of the houses calling them out from their house taking photographs of their house asking them vote for BJP candidate Kripa Nath Mallah and or they will be evicted from their house by Bull- Dozer after 07/06/2024.

- 6. They are also marking the trees in our 50/60 years old houses, by the side of village paths which was never done earlier in last 40/50 years parents were residing.
- 7. That the officials/accuseds has very badly threatened us and have used very intimidating/threatening and abusive language threatening us to vote for BJP candidate and or else will be evicted. In some areas residents were called at night through the staff/ police/commandos to the Cheragi Forest Office and were called to office room in twos, strictly keeping the Mobile Phone outside, so that none can take photo or record the verbal orders, and were asked to vote for BJP or else will be evicted.
 - 8. Thus it is a clear case of Criminal Intimidation, and insult deliberately committed by the accuseds.
 - 9. That it is very unfortunate that the accuseds being regular Govt Servants are using their official capacity in such an illegal and criminal manner threatening/intimidating and insulting the complainants/victims openly and publicly.
 - 10. That there is no hope of getting impartial investigation of the case, so we have chosen this forum for justice.
 - 11. That there are innumerable Photograps and Videographs of the incidents available with the complainants. Those may be allowed to be produced/exhibited as and may be required by this Hon'ble Court for the proper trial of the case.

Under the facts and circumstances it is most humbly prayed that your Honour may be kind enough to take cognizance of the case, to order for
